

The Board of Logan County Commissioners met on Monday, July 2, 2018. Those present were Commissioners Cameron Edwards and Carl Uhrich. David Hubert was absent. The meeting was called to order at 8:30 a.m. by Chairman Cameron Edwards.

It was moved and seconded by Commissioners Uhrich and Edwards to approve the agenda as presented. Motion carried 2-0.

Vicki Hubin with Western Kansas Child Advocacy Center met with the Board requesting 2019 budget consideration in the amount of \$5,000.00. She explained the services that are provided including mental health services, prevention, medical services as well as the mobile therapy units. The Board allocated \$5,000.00 in 2018 and agreed to consider her request for 2019. The Board also signed a Notice and Waiver to help support Western Kansas Child Advocacy Center.

Jerry Michaud from Developmental Services of Northwest Kansas, Inc. presented the Board with their 2017 Annual Report and thanked the County for their contributions every year. Discussion was held regarding their services and the economic impact to the County. Michaud requested 2019 budget consideration in the amount of \$28,000.00. The Board allocated \$28,000.00 in 2018 and agreed to consider his request for 2019.

The minutes from the June 18, 2018 meeting was reviewed. It was moved and seconded by Commissioners Uhrich and Edwards respectively to approve the minutes. Motion carried 2-0.

The Board reviewed the Warrant Register dated June 29, 2018 as follows: General \$19,190.87; County Health \$6,769.77; Road & Bridge \$20,438.05; Noxious Weed \$8,442.95; Multi County Health \$40.00; Fire \$4,792.63; EMS \$4,265.67; Special Equipment Road \$200,870.37; Capital Improvement \$1,524.18; Drug Forfeiture \$2,010.97; Co Attorney Drug Forfeiture \$149.18; Special Sheriff VIN \$200.00; Payroll Clearing \$2,690.86 for a total of \$271,385.50. It was moved and seconded by Commissioners Uhrich and Edwards respectively to approve the Warrant Register as presented. Motion carried 2-0.

The Board reviewed the 20.5 hours of overtime for the Custodian and 19 hours for the Weed Department for June.

The Board reviewed the June 29, 2018 Payroll Register as follows: General \$42,307.74; County Health \$12,370.09; Road & Bridge \$21,547.05; Noxious

Weed \$4,673.00; Fire \$12,617.16; EMS \$12,563.07 for a total of \$106,078.11. It was moved and seconded by Commissioners Uhrich and Edwards respectively to approve the Payroll Register as presented. Motion carried 2-0.

There being no further business discussed it was moved and seconded by Commissioners Uhrich and Edwards respectively to adjourn the meeting at 10:10 a.m. The next regular meeting is scheduled for Monday, July 16, 2018 at 8:30 a.m.
