

The Board of Logan County Commissioners met for a special meeting on Thursday, February 23, 2023. The purpose of the special meeting was to discuss non-elected personnel. Those attending were Commissioners David Hubert, Cameron Edwards, Cody Younkin and Road Supervisor Paul Lorenzen. Chairman Hubert called the meeting to order at 8:00 a.m.

At 8:00 a.m. it was moved and seconded by Commissioners Younkin and Edwards to go into executive session for one hour to discuss non-elected personnel. Motion carried 3-0. At 10:55 a.m. it was moved and seconded by Commissioners Younkin and Edwards to go into executive session for 20 minutes to discuss non-elected personnel. Motion carried 3-0. Those present in the session were Commissioners Edwards, Hubert, Younkin and Jason Racette. The Board returned to open meeting at 11:15 a.m.

At 11:15 a.m. it was moved and seconded by Commissioners Younkin and Edwards to go into executive session for 25 minutes to discuss non-elected personnel. Motion carried 3-0. Those present in the session were Commissioners Edwards, Hubert, Younkin and Nate Hales. The Board returned to open meeting at 11:40 a.m.

At 11:40 a.m. it was moved and seconded by Commissioners Younkin and Hubert to go into executive session for 25 minutes to discuss non-elected personnel. Motion carried 2-0. Those present in the session were Commissioners Hubert, Younkin and Randy Moore. The Board returned to open meeting at 12:05 a.m.

It was moved and seconded by Commissioners Younkin and Hubert to place Road Supervisor Paul Lorenzen on administrative leave until further notice. Motion carried 2-0.

It was moved and seconded by Commissioners Hubert and Younkin respectively to adjourn the meeting at 12:10 a.m. Motion carried.
